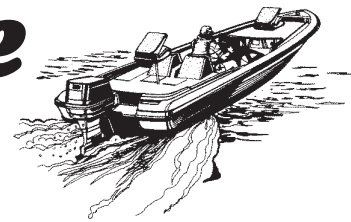


# **Forest County's Lake Courtesy Code**



*Please follow these  
common sense courtesies:*

## **NOISE - Sound travels far over water.**

- Recommended water skiing and jet skiing hours: 10 a.m. to 5 p.m.
- Quiet hours please - after 10 p.m.

Please Note: Hours may vary by lake

## **SPEED - Give other lake users a break**

- Slow down for safety, and to protect shorelines from erosion.
- Watch for no-wake zones and speed limits.

## **SPACE - Keep your distance**

- Boaters - Stay at least 100 ft. from swimmers, divers, anglers, other watercraft, rafts and docks. (state law)
- Observe loons, eagles, and other wildlife from a long distance.

## **SAFETY - State Laws**

- Jet skiers - stay at least 200 ft. from shore when operating faster than "slow-no-wake" speed.
- All watercraft - observe 200 ft. from shoreline to protect valuable habitat.
- Waterskiing and jet skiing - not permitted after sunset.
- Reminder - one wearable personal flotation device is required for each person in a watercraft.

## **CLEAN BOATS/CLEAN LAKES - It's up to us**

- **STATE LAW** - Launching boats or boating equipment with aquatic plants or zebra mussels attached is prohibited. Clean your boat, motor, trailer, anchor, and live-well to prevent the spread of Eurasian watermilfoil and other exotic species.
- Litter kills wildlife - if you carry it in, please carry it out.

## **PLEASE: NO POWER LOADING OF WATERCRAFT**

Perform lake CPR - be Courteous, Polite, & Respectful.

Help keep our lakes safe, clean and enjoyable for everyone.

## WALKER SIGNS BILL TO PROMOTE FISH HABITAT ON WI LAKES

Senate Bill 315 was signed into Law by Governor Scott Walker March 1, 2016. Senate Bill 315 was authored by Representative Swearingen and Senator Gudex (R - Fond du Lac) at the request of the Lake George Association and others in the 34th Assembly District.

Senate Bill 315 was drafted to improve fish and wildlife habitat on Wisconsin waterways by removing civil liability from property owners placing Department of Natural Resources (DNR) permitted structures in navigable waters and wetlands. Senate Bill 315 will keep the rules and regulations in place for all permits, while removing liability if and when the DNR specifications are met. This proposal will continue to protect our environment through DNR permits and specifications while boosting fish habitat statewide.
